



**IMPORTANT SAFETY RECALL**  
**NHTSA ID # 23V-685 // HT Campaign # 801500**

**This notice applies to your Hyundai Translead Tri-Axle Chassis on BOM# 30021498 (3 units). VIN list attached.**

October 18<sup>th</sup>, 2023

Dear [REDACTED],

We are conducting a safety recall and this notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai Translead has decided that a defect which relates to motor vehicle safety exists in certain 20’/40’ 12 Pin Tri-Axle chassis.

**Important!**

- Your Extendable Tri-Axle chassis falls within the recall population
- You should avoid use and schedule an appointment with Hyundai Translead to have your unit retrofitted.

<b>Why is a technical service bulletin being conducted?</b>	We discovered that the (3) cross braces that sit just above your chassis air tanks could potentially have incomplete welding. In the worst-case scenario, if the welds break it could cause the cross brace to fall off of the unit and cause a road accident, or it could hit an air tank airline which in turn could result in an unwanted brake lock / air issue which could also cause an accident.
<b>What are we doing about the problem?</b>	To prevent this issue, we are asking to place the units out of service so we can apply a retrofit which consists in: <ol style="list-style-type: none"> <li>1. If original weld was in place but incomplete, we will complete the weld and add weld on top of the diagonal braces as well.</li> <li>2. If original weld is missing or was applied to less than 50%, we will weld a bracket to the diagonal braces in addition to fixing the existing welds and adding the top weld.</li> </ol>
