On November 30, 2023, Forest River's Office of Corporate Compliance ("OCC") was by the manufacturing plant that during inventory, it was discovered that the taillamps did not have the correct marking for reflex reflector.

On December 1, 2023, OCC opened a research item. OCC asked the manufacturing plant for the inscription on the taillamp in question for review.

On December 8, 2023, Forest River's Corporate Recall Committee voted to recall. A Stop Sale Notice is being issued immediately following the recall filing.
