Description of Defect:

Description of the Defect: The brake fluid pipe flare nut installation torque for the brake fluid supply lines

attached at the anti-lock brake system module (ABS module) that supply the front and rear brake calipers may have been tightened to less than the correct torque specification. In the worst-case, the flare nuts could loosen over time and brake fluid could leak from the ABS module body at the pipe connections. If a pipe connection allows fluid leakage, brake system performance could be affected. In the worst case, compliance with FMVSS 122 may not be met.

FMVSS 1: 122 - Motorcycle brake systems

Description of the Safety Risk: Brake fluid leakage could result in an increase in brake lever/pedal travel and

reduced braking performance, increasing the risk of a crash.

Description of the Cause: The assembly process documentation lacked clarity and production-line
