Notice of Defect – 2006 to 2007 Model Year Lamborghini Murciélago Coupè and Roadster
Installation of clutch pedal switch – Campaign n° 08 - 121

Dear Sir or Madam:

This notice is sent to you in accordance with the requirements of Transport Canada Motor Vehicle Safety Act.

Automobili Lamborghini S.p.A. has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2006 to 2007 Lamborghini Murciélago.

In the course of continuous product monitoring, Automobili Lamborghini S.p.A. has found that the clutch pedal switch was not installed on your vehicle. The engine could therefore be started without the clutch pedal being depressed. If the transmission were in gear when the engine is started without the clutch pedal depressed, the vehicle can experience movement in the forward or reverse direction unintended by the driver and an accident could possibly occur.

For safety reasons it is therefore necessary to update your vehicle and install a clutch pedal switch. Your vehicle is one of the models affected.

We therefore kindly request you to make your vehicle available for a maximum of 1 to 2 days so we can carry out the necessary repairs. This work will, of course, be carried out at no charge to you.

Transport Canada regulations require that any vehicle lessor receiving this Notice of Defect forward a copy to the lessee within 10 days.


