SUBJECT: Safety Recall S42 – Center Seatbelt Bezel(s)

In an effort to provide enhanced support and communication for open campaigns, FCA and Mopar ask that you read this important announcement regarding the S42 safety recall. FCA US LLC has decided that a defect, which relates to motor vehicle safety, exists in certain 2017 model year Chrysler Pacifica vehicles.

The center seatbelt bezel(s) on about 3,616 of the above vehicles may break and trap the seatbelt in the stowed position. This could prevent the use of the seatbelt in the center third row and/or three-passenger center second row seating positions. An unbelted occupant could suffer additional injuries and/or become a projectile within the vehicle, injuring other vehicle occupants, during a crash. The third-row center seat belt bezel and the second row center seat belt bezel (if equipped) must be replaced.

S42 Center Seatbelt Bezel(s) Parts Plan / Rate of Supply

- An initial allocation of parts will be distributed to dealers beginning 7/1/2016 with subsequent shipments allocated to cover the majority of units prior to parts ordering availability.
- The Seat Belt Bezel(s) (5YD63PD2AC & 5XY48PD2AC) will be on an initial order restriction of 1 piece every 7 days as additional parts supply is received and packaged.
- Please refrain from ordering incremental S42 parts inventory through the expediting Web Request
 process as Mopar works to procure additional parts supply. Mopar Supply Chain will automatically
 distribute incoming parts as they become available. Parts for the first few weeks will be coming Next
 Day Air direct from the packager.
- The Campaign Order Management Guide located in Recall Central is updated weekly. It will reflect when the part supply is no longer limited and the ordering restriction is removed.
