Double wishbones
Your Lamborghini Gallardo with chassis number:

Dear Sir or Madame,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Automobili Lamborghini S.p.A has decided that a defect which relates to motor vehicle safety exists in certain model year 2006 Lamborghini Gallardo.

In the course of continuous product monitoring, Automobili Lamborghini S.p.A. has found that the bolted connections on the double wishbones may come loose over time or under extreme loading. This could lead to a reduction in handling stability which could result in a crash.

For safety reasons it is therefore necessary to check and, if necessary, repair these vehicles. Your vehicle is one of the models affected.

We therefore kindly ask you to make your vehicle available to us for a maximum of 1-2 days so that we can carry out the necessary checks and repairs. This work will, of course, be carried out at no charge to you.

Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

Please contact an authorised Lamborghini Dealer or Service Point without delay to make an appointment. Please bring this letter and your Service Schedule with you when you visit the workshop, so that we can make all necessary entries.




