This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Automobili Lamborghini SpA has decided that a defect, which relates to motor vehicle safety, exists in the model year 2007-2008 Murciélago (version LP640).

Lamborghini has determined that it is possible for welds holding the fuel pump support inside the fuel tank of the model year 2007-2008 Murciélago Coupè and Roadster (version LP640) to detach. This situation, though rare, may result in a slow fuel leak which could potentially result in a fire only if an external ignition source is present.

For safety reasons it is therefore necessary to repair these vehicles.

**Your vehicle is one of the models affected.**

Please contact an authorized Lamborghini dealer immediately to arrange an appointment. Please bring this letter and your Service Booklet with you when you visit the dealer, so that we can complete all of the necessary documentation.

If you detect the odour of fuel or observe fuel on the ground, please contact your Lamborghini dealer to get your vehicle towed to service.

Your dealer will replace the fuel tank, which will take a maximum of 2 business days. This work will, of course, be carried out at no charge to you.

**Any Lessor that receives this notification must send a copy of this notice to the Lessee.**
