



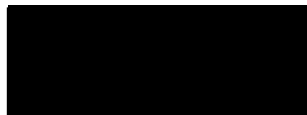

Dear Mitsubishi Fuso Truck Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mitsubishi Fuso Truck of America, Inc. has decided that a defect which relates to motor vehicle safety exists in the fuel return hose on certain 2012 - 2015 model year FEC52, FEC72, FEC92, and FGB72 Mitsubishi Fuso trucks. On certain affected vehicles, the fuel return hose is comprised of a material that deteriorates when subjected to various chemicals and lubricants, such as those used when cleaning the vehicle or used in certain rear body applications. Normal vehicle operation and maintenance may cause the fuel return hose to swell and come off, resulting in a fuel leak. In the worst case, the fuel could ignite, resulting in an engine fire.
