



Important Safety Recall: NHTSA Campaign # 16V-580

This notice applies to your Hyundai Translead Trailers on BOM# 30009441 (237 units), 30009858 (45 units) and 30010859 (1 unit). VIN list attached.

Dear Don Davis and ABF Freight Systems Inc.,

We are conducting a safety recall and this notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Bendix Commercial Vehicle Systems has decided that a defect which relates to motor vehicle safety exists on the Bendix Spring Brake Valve K033086 Series.

Important!

- Your trailer falls within the recall population
- You should avoid use and immediately schedule an appointment with Bendix to have your Spring Brake Valve replaced.

| Why is a recall being conducted? | During transition to a new valve body supplier, a check valve seat radius dimension was inadvertently omitted from a revised drawing. Because of this, under certain conditions, primarily off-highway or in trailer yards, there can be a delay in the application of the spring brakes to park the trailer after the operator pulls the dash valve button. This slow to park condition may lead to trailer roll away after decoupling from the tractor, increasing the risk of crash. |
| What are we doing about the problem? | The trailers listed are to be inspected for the defective valve. If found defective valve, it would be replaced free of charge. |
| What should you do? | Please contact Bendix Recall Assistance Center at 877-345-9526 as soon as possible to schedule an appointment. You should avoid extended travel until your Spring Brake Valve is replaced. When contacting Bendix make sure to reference NHTSA Campaign Number: 16E-045 and provide the full VIN number. | What if I no longer own this trailer? | Please notify Hyundai Translead either by phone: 800-251-0871, or e-mail: warranty@translead.com to inform us you no longer own this vehicle. Please be sure to include your 17 digit VIN number in all correspondence. |
