3.7L Ti-VCT - Illuminated Malfunction Indicator Lamp (MIL) - Diagnostic Trouble Code (DTC) P0420 And/Or P0430

2013-2018 Police Interceptor Utility

Issue: Some 2013-2018 Police Interceptor Utility vehicles equipped with a 3.7L Twin independent-Variable Camshaft Timing (Ti-VCT) engine may exhibit an illuminated MIL with DTC P0420 and/or P0430.

Action: Follow the Service Procedure steps to correct the condition.

Service Procedure

- 1. Using the appropriate Ford scan tool or equivalent, retrieve DTCs. Are P0420 and/or P0430 the only DTCs stored in the powertrain control module (PCM)?
 - (1). Yes replace the affected catalytic converter per the DTC. Refer to Workshop Manual (WSM), Section 309-00.
 - (2). No this article does not apply. Refer to Powertrain Control/Emission Diagnosis (PC/ED) Manual for normal diagnostics.
- 2. Is the vehicle built on or before 25-Apr-2014?
 - (1). Yes reprogram the PCM using the appropriate Ford scan tool release 90.02 or higher. Make sure you are connected to the internet when entering module programming to obtain the latest updates.
 - (2). No repair is complete.
