SUBJECT:

Flash: Transmission Diagnostic and Shift Enhancements

OVERVIEW:

This bulletin involves reprogramming the Transmission Control Module (TCM) with the latest available software.

MODELS:

2015 - 2016	(BU)	Jeep Renegade
2016	(FB)	FIAT 500X

NOTE: This bulletin applies to vehicles within the following markets/countries: EMEA.

NOTE: This bulletin applies to vehicles equipped with a 1.4L I4 Multiair Turbo Engine (Sales Code EAM) and a 9-SPD 948TE Auto Transmission (Sales Code DFH).

SYMPTOM/CONDITION:

Customers may experience a Malfunction Indicator Lamp (MIL) illumination. Upon further investigation the technician may find one of the following DTCs have been set:

- **P0887 TCM Power Control Circuit High.**
- P061B Internal Control Module Torque Calculation Performance.
- P072F Stuck In Fourth Gear.
- P0711 Transmission Fluid Temperature Sensor A Circuit Range-Performance (2015 BU Only).
- P1CC9 Unable to Engage Gear (2015 BU Only).
- P1D98 Incorrect Gear Ratio Clutch B or D Defective (2015 BU Only).
- U0401 Implausible Data Received From ECM-PCM (2015 BU Only).

In addition, customers may notice the following condition(s):

- Harsh 1-2 upshift.
- Harsh garage shifts (Park to Reverse or Drive).
- CAN bus message may drop out after a network restart.

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in TechCONNECT, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If the customer describes the symptom/condition listed or if the technician finds the DTC, perform the Repair Procedure.

REPAIR PROCEDURE:

NOTE: The Powertrain Control Module (PCM) must be updated to the latest available software at the conclusion of this repair procedure. Refer to all applicable published service bulletins for detailed repair procedures and labor times regarding updating the PCM software.

NOTE: Install a battery charger to ensure battery voltage does not drop below 13.2 volts. Do not allow the charging voltage to climb above 13.5 volts during the flash process.

NOTE: If this flash process is interrupted/aborted, the flash should be restarted.

- 1. Reprogram the TCM with the latest software. Detailed instructions for flashing control modules using the wiTECH Diagnostic Application are available by selecting the application's "HELP" tab.
- 2. Clear any DTCs that may have been set in any module due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allows them to be cleared.
- 3. Verify the PCM is programmed with the latest available software. Refer to all applicable published service bulletins for detailed repair procedures and labor times regarding updating the PCM software.

Reimbursable within the provisions of the warranty.

FAILURE CODE:

- **The dealer must use failure code CC with this Service Bulletin.
 - If the customer's concern matches the SYMPTOM/CONDITION identified in the Service Bulletin, failure code CC is to be used.
 - When utilizing this failure code the 3C's (customer's concern, cause and correction) must be provided for processing Service Bulletin flash/reprogramming conditions.**
