## **Warranty Extension: IMA Battery**

### **AFFECTED VEHICLES**

Year	Model	VIN Range
2009–11	Civic Hybrid	Check the iN VIN status for eligibility

#### **BACKGROUND**

To improve customer confidence, American Honda is extending the warranty coverage on all 2009–11 non-PZEV Civic IMA battery modules to match the PZEV warranty, which is 10 years or 150,000 miles, whichever comes first.

There is no change to the warranty on 2009–11 PZEV Civic IMA battery modules.

NOTE: The junction board is not covered under this warranty extension.

- You must be fully certified in the Electrical Fundamentals map, and have completed training modules MAC 10 and
  12 on the Electrical Systems map, in order to do junction board and IMA battery module replacements.
