## BACKGROUND

While driving, the vehicle shifts into Neutral, the transmission indicator comes on and DTC P0657 (actuator supply voltage circuit/open) is stored. The driver will not be able to select any other gear until the vehicle is turned off and restarted.

# **CORRECTIVE ACTION**

Update the PGM-FI software and the TCM software, clear any DTCs, and do the PCM idle learn procedure.

## **CUSTOMER NOTIFICATION**

Owners of affected vehicles will be sent a notification of this campaign.

Do an iN VIN status inquiry to make sure the vehicle is shown as eligible.

Some vehicles affected by this campaign may be in your new or used inventory. Repair these vehicles before they are sold.

NOTE: For California dealers only, make sure to give your client a Vehicle Emission Recall - Proof of Correction certificate. See REPAIR PROCEDURE for ordering information.

## REPAIR PROCEDURE

1. Update the PGM-FI software first, then update the TCM software with the MVCI. Refer to Service Bulletin 01-026, *Updating Control Units/Modules*.

NOTE: On vehicles equipped with auto idle stop, the MVCI may indicate error code 56 during the update. If you see the error code, open the hood, turn off the auto idle stop by turning off the switch in the center console area, and do the update again leaving the hood open.

- 2. Clear any stored DTCs with the HDS.
- 3. Do the PCM idle learn procedure. Refer to the service repair information.
- 4. For California residents only: Fill out a Vehicle Emissions Recall Proof of Correction certificate, and use 5YJ as the recall number. Give the certificate to your client, and advise him or her to keep it as proof that the product update was completed. Your client will need to submit this certificate to the DMV only if the DMV requests it. NOTE: If you need more certificates, use reorder number Y0657.
