INTRODUCTION

This bulletin announces the availability of new reprogramming files for optimizing the ECM to address the following customer concern:

• Rough idle after a warm engine restart. In rare cases, DTC P0300 may also be stored.

PRODUCTION CHANGE INFORMATION:

The new logic was incorporated into production starting with the following VINs:

WRX: F*818365

Forester Turbo: FH539953

NOTE: These files have been incorporated into production on both models at the start of 2016MY production. Although these vehicles were produced with the programming for the conditions covered by Service Campaign WQW-58, they did not include the programming for the above listed condition at the time of production. Not all vehicles will experience the above listed conditions. Since WQW-58 was released concurrently with the development of this programming and since program files are cumulative in nature, the WQW-58 files also include this programming enhancement. Hence, the same files are used for both applications.

SERVICE PROCEDURE / INFORMATION

NOTES:

SOA now highly recommends connecting the Midtronics GR8 Diagnostic Battery Charger to the vehicle and utilizing the Power Supply Mode feature anytime a vehicle control module is being reprogrammed. Once the GR8 is connected to the vehicle, as long as the battery is fully charged, it takes less than 3 minutes to boot-up the charger, select the Power Supply Mode, and have the battery voltage stabilized and ready for reprogramming.
