To export a session log from GDS2 and attach to a TAC case using the Dealer Case Management tool, perform the following:

1. Launch GDS2 and click Review Stored Data as shown below.



2. Click on the Edit Button as shown below.


3. Click on the Check Box next to the session log that you would like to email to TAC and then click the Export Button as shown below.


4. Save the Session Log file to the Computer's Desktop as shown below:

5. Once the GDS2 Session Log has been saved to the computer's desktop, right click on the file and select "rename", change the file extension from .zip to .piz (this will allow for the file to properly attach to the TAC case):



6. To upload the GDS2 Session Log, click on the "Add Attachment" tab in the Dealer Case Management tool:
