SUBJECT: DTC C0075 Repair Information

INTRODUCTION:

This bulletin announces a change to the internal logic of the ABS / VDC Hydraulic Control Unit. The change was made to address isolated concerns of the ABS and / or VDC warning lamp(s) coming on in error and setting a DTC C0075: <WHEEL CYLINDER PRESSURE SENSOR OUTPUT> in memory. A logic change was made to optimize the failure detection criteria. The repair involves replacement of the ABS / VDC Hydraulic Control Unit as the unit's software cannot be reprogrammed.

REMINDER: Always order the most up-to-date replacement parts based on the specific VIN being repaired.
