
### INTRODUCTION:

This Service Information Bulletin announces design changes made to the ignition coil and engine wiring harness in response to a limited number of cases related to the ignition coil primary / secondary DTCs listed above. The changes involve a shape change to the harness connector on the coil and to the corresponding engine harness connector. A positive lock mechanism has also been added to the engine harness ignition coil connectors to reduce the chances of becoming disconnected and causing a driveability concern and / or DTC(s).

### PRODUCTION CHANGE INFORMATION:

The new parts were incorporated at the start of 2015MY vehicle production.
