

TECHNICAL SERVICE BULLETIN Illuminated Airbag Warning Indicator With DTC B1404:13 And/Or B1407:13

Model:

Ford 2021 Bronco 2020-2021 Explorer Lincoln 2020-2021 Aviator

Issue: Some 2020-2021 Explorer/Aviator and 2021 Bronco vehicles may exhibit an illuminated airbag warning indicator with diagnostic trouble code (DTC) B1404:13 and/or B1407:13. This may be due to contamination and relative movement in the connection between the wiring harness and the side airbag. To correct the condition, follow the Service Procedure steps to replace the affected connector with a service pigtail and the affected side airbag.

Action: Follow the Service Procedure steps on vehicles that meet all of the following criteria:

- One of the following vehicle lines:
 - 2020-2021 Explorer/Aviator
 - 2021 Bronco
- Illuminated airbag warning indicator with DTC B1404:13 and/or B1407:13

NOTE: Part quantity refers to the number of that service part number required, which may be different than the number of individual pieces. Service part numbers contain 1 piece unless otherwise stated. "As Needed" indicates the part is required but the number may vary or is not a whole number; parts can be billed out as non-whole numbers, including less than 1.

Service Procedure

1. Remove the affected side airbag. Refer to Workshop Manual (WSM), Section 501-20B.

NOTE: It is not required to remove the front seat from Explorer/Aviator vehicles.

- 2. Remove connector C367 and/or C337.
- On Explorer/Aviator vehicles, replace connector C367 and/or C337 with the service pigtail. Refer to Wiring Diagram Cell 005.
- **4.** On Bronco vehicles, replace the 14A699 seat wiring harness.
- **5.** Make sure the wiring harness is pulled outboard of the seat frame to prevent strain on the connector after replacing the side airbag. (Figure 1)

6. Replace the affected side airbag. Refer to WSM, Section 501-20B.
