Due to supply issues, it is necessary to build a certain quantity of 2016 Silverado and GMC Sierra 1500 and HD trucks without Apple CarPlay and Android Auto compatibility.

The affected trucks will be built with the 2.0 HMI module, which was previously used on 2015 Silverado and Sierra 1500 and HD trucks.

If for any reason the dealer needs to replace the HMI, it needs to be replaced with the correct HMI 2.0 part.

2. The Vehicle Invoice will contain the RPO code "CPO" (letter O) and the \$200 (\$225 in Canada) credit.
